But for now all parties and their representatives must be ready to work across all UPC jurisdictions, including some local and regional divisions which are not especially well known for patent litigation.

It's likely Ireland will look to establish a local division in the UPC in the next few years. Like the UK, Ireland has a common law system, and parties who wish to follow common law litigation procedures — such as disclosure, experiments or testimony from experts — may look to the Irish Local Division.

Whilst certain steps, such as a referendum, are needed before Ireland can participate in the UPC, our discussions with authorities in Dublin suggest that Ireland is aware of the potential opportunities that the UPC may bring to the country and is keen to exploit them. This would further increase the advantages to be gained from common law expertise.

Unlike continental firms established in civil law jurisdictions, we're well placed to give you an advantage in exploiting the common law aspects of the system before any local or central division in the UPC.
